### Son of Zambia

I was born in Kitwe, Zambia, formerly Northern Rhodesia. Was the 2nd child out of 4. My eldest sister is Anne. As a child, for high school I had to go out of the country. I went to St. Georges, a Jesuit school in Salisbury in S. Rhodesia. Went by train. 1000 miles away! Came home 3 times per year. It was a "school train." Boys were in one car of the train, girls were in another, and in the car in between was a restaurant. Train monitors were very strict about boy/girl mixing. Sometimes there was an organized dance in the restaurant.

The trip took 3 days and 2 nights. Had to switch trains in Bulawayo. My friends and I got off the train at Livingston. Took a taxi to Victoria Falls Hotel. On the way saw the falls! At the hotel, boys would hide in the garden to drink and smoke. (Good times!) NEVER GOT CAUGHT.

Summers considered not healthy to be in Zambia (due to high risk of getting malaria). So, I went to South Africa for 6 weeks. Had family there.

After high school there was no graduation like there is today. No ceremony. After I got my degree after "varsity "(university) then there was a graduation ceremony. My degree was in Social Work. It was considered part of the sciences. When I was training, I worked in the slums in Johannesburg. I decided that Social Work was not the field for me. I didn't know what I wanted to do. Also, my country's government changed. Northern Rhodesia became Zambia.

I left to go England. My degree was useless there. I worked in a variety of jobs such as in an income tax department, and also as an inspector for an exterminator company. At this company I worked with a cast of characters!

I met a man who was an antique dealer. I worked for him buying and selling antiques. They were dated to the time from before 1830.

After that I met a man who was planning to open an antique dealership in Virginia. This is when I moved to the United States. The job was a disaster and I moved on but I stayed in the U.S.

This was around 1972. I was looking for jobs in the want ads and found a job at a furniture dealer. I was living in Florida. I took classes in interior design and decided that I wanted to work in this field. Through connections with friends, I eventually took a job with a furniture dealer in New York, and I was happy.
